FROM THE ASSESSOR'S DESK

Thinking of selling your home? Now may be a good time as home values have shown a marked increase this past year.

Disabled Veteran's Exemption: Disabled veterans may receive up to a 100% exemption on property taxes if they qualify. They must be a Michigan resident, own the property for which they are claiming the exemption, and use the property as their homestead. Unremarried surviving spouses may also qualify. The disabled Veteran is eligible if they have been determined by the VA to be

permanently and totally disabled as a result of military service and entitled to benefits at the 100% rate, have received pecuniary assistance due to disability for specially adapted housing, or be rated as individually unemployable. If you think you may qualify, contact me for eligibility requirements.



Notice of Assessment, Taxable Valuation and Classification: Look for your notice to come out in late February. Check this notice for your classification, principal residence exemption %, current and prior year assessed and taxable values, and March Board of Review appeal dates.

NO WIPES IN THE PIPES

Just because a product is marked disposable or flushable does not mean it won't play havoc with your sewer or septic system. All across the country communities are experiencing serious back-ups that are attributed to an increase in items such as wipes, napkins, paper towels, personal hygiene products, and dental floss being flushed. This is leading to serious maintenance problems and costly clean-ups. Our advice is to keep the wipes out of the pipes. Use them, but don't flush them.

Don't forget to change the batteries in your smoke detectors every six months. Every home should also have a good quality carbon monoxide (CO) detector.

2016 Election Dates

Presidential Primary: March 8 May (if needed): May 3 August Primary: August 2 November General: November 8

You must choose either a Republican Party or Democratic Party ballot for the March 8, 2016 Presidential Primary only. Absentee ballot applications are available on the web at www.michigan.gov/vote, or from the clerk's office at 866-0622. If you have questions about your voter registration or precinct, call my office or go to www.michigan.gov/vote.

Voter Eligibility: You are qualified to vote if you are a U.S. citizen, are at least 18 years old on or before election day, have been a resident of Michigan

for at least 30 days before the election, and you have registered to vote on or before the close of registration. Note: Michigan Law requires that the same residential address be used for both your voter registration and your driver's license.

Running for Township Office: All seven township offices will be up for election in 2016: Supervisor, Treasurer, Clerk and four Trustees. To qualify to run for township office you must be a township elector, but property ownership is not required. An elector is someone who is 18 years old, a U.S. citizen and has lived in the township for at least 30 days. The deadline for filing nominating petitions for the August 2nd Primary is April 19, 2016. Materials are available in the clerk's office and online at www.michigan.gov/sos. Terms of office are four years.
