SUPERVISOR NOTES

We have been made aware of two possible positive PFAS test results in Courtland Township. One is located off Peninsula Dr. and the other is just north of 10 Mile Rd. on Myers Lake Ave. Both tests resulted in very low concentrations of PFAS, under 10 parts per trillion (PPT), well below the benchmark set by the MDEQ.

It is our understanding the samples were drawn by Gordon Water, a local water treatment company, and sent to a certified lab for PFAS testing. The MDEQ is not disputing the result, but they are unable to determine how the samples were collected. While not validating the results, the MDEQ stated if a much higher result is attained (30 or 40 PPT) they would like to be notified.

Gordon is currently charging the private home owners \$300 to test for PFAS. Fleis & VandenBrink, an engineering company in Grand Rapids, follows scientific protocols for collection and will test private homes for \$500 a home (minimum 10 homes) per the MDEQ.

In closing, there are still no identified dump sites in Courtland Township. The MDEQ and the Kent County Health Department are handling all official investigations and the testing in this matter.

We also are finishing up our Disc Golf course near the Township Hall. Thank you to Rockford Community Endowment for grant monies received to offset the cost.

Courtland Township also purchased the old fishery on 10 Mile Rd. with plans of making this area a park. 90% of the purchase price was funded by grants from Ducks Unlimited, the NAWCA Grant Land Acquisition, and Schrems Trout. Thanks to Josh Zuiderveen for his assistance with this

WINTER 2018

Taxes are due by 4:30 PM on Wednesday, February 14, 2018; additional interest applies after this date.

Thursday March 1, 2018 all taxes still owed will be sent to the Kent County Treasurer's office. The Kent County Treasurer keeps all records of delinquent taxes and can be reached at (616) 632-7500.

PAYMENT OPTIONS:

In Person: A cashier or personal check is preferred, we do not accept Credit card payments at the office. If paying in cash, please bring exact amount.

By Mail: For a receipt, please enclose a stamped, self-addressed envelope and your entire tax bill. It must be **received** by the Courtland Twp office by February 14, 2018. Postmark date not accepted.

Drop Box: A payment drop box is located by the front door. This box is safe and checked regularly.

Online Payments: Follow the link from our website: www.courtlandtwp.org. Credit card or e-check payments can be made. Convenience fees apply. The Treasurer's office is not responsible for payments made for the wrong parcel.

MORTGAGE ESCROW PAYMENTS: We sent your tax bill to the mortgage company IF the mortgage company requested the bill. The message" Informational Copy" means that your tax bill has been sent to your mortgage company or the Tax Service they utilize. This is printed in the "Tax Detail" portion of your tax bill on the right side. If your taxes are escrowed and your bill wasn't sent to your mortgage company, make a copy of the bill for your records and forward the original tax bill to your mortgage company.

PRINCIPAL RESIDENCE EXEMPTION: Check your tax bill to make sure you are receiving the PRE if you qualify. To qualify for this year, you must own and occupy your residence before June 1st, 2017 for Summer and Nov. 1st 2017 for Winter.

Courtland Township Annual Budget is adopted at our March Regular Township Board Meeting yearly. Our fund balances are available upon request at the Treasurer's Office.

The State of Michigan offers help to eligible taxpayers in the form of the Property Tax Credit, Home Heating Credit, and Military Tax Relief. For more information visit www.michigan.gov/taxes.

FROM THE FIRE CHIEF'S DESK

Please change your batteries in your smoke detectors and carbon monoxide detectors. Did you know you should replace the whole detectors every 10 years? We have FREE smoke detectors at the Township Hall and fire station.

CARBON MONOXIDE: Carbon monoxide (CO) is the number one cause of poisoning death in the U.S. It is odorless, colorless, and exposure can be fatal. Common sources of CO are faulty furnaces, auto exhaust fumes, heaters, indoor stoves, gaspowered generators, cigarette smoke, and smoke from charcoal-fired stoves. Install a CO detector in addition to your smoke detector. Call 911 and leave the area if your CO alarm goes off or if you experience symptoms of CO poisoning such as flulike symptoms, fatigue, confusion, nausea, vomiting, diarrhea, headaches, dizziness, or weakness.

BURN PERMITS: Before you burn, email firechief@courtlandtwp.org or text/call 616-813-2961. Please let us know your name, address, phone number and the time/date you plan to burn. Remember, all burning must be done during daylight hours, and burning should be a safe distance from all buildings and tall grass and trees. Do not leave fires unattended and have a garden hose handy. Burning of tires, roofing, construction materials, treated lumber, garbage, plastics or rubber or petroleum products is prohibited.

911 EMERGENCY ADDRESS SIGNS: We can usually find your place when it's on fire, but when you are having a Medical Emergency and you do not have your address out by the road where we can see it, it might mean life or death for you or a family member.

We have Green & White reflective address signs available for \$10. Call the Township Hall order one.

CHRISTMAS TREES: Please keep them watered so they won't dry out and become a fire hazard. They may be dropped off through Jan 31st behind Fire Station (14 Mile), on the south side of the driveway. Please remove all ornaments, tinsel, and plastic bags.

Want to be a Fire Fighter? We are always looking for help! No experience is needed; we will train you! Please stop by and see me at the Station, M-F, 7:30 am to 4:30 pm.

FROM THE ASSESSOR'S DESK

PA 489 of 2016 abolished Dower Rights with an effective date of April 6, 2017. As of that date, our department will no longer be changing ownership on a parcel from a husband's death certificate. We will need to see a legal document with the wife in title also. Please check the ownership of your parcel with our records. If the wife is on the title already and not listed as owner in our system, please provide me a copy of the instrument (i.e. deed, land contract, court order, death certificate before April 6, 2017, etc.), and we can add her. Our older software system only accommodated the husband's name, so this may need to be updated.

For more in-depth questions pertaining to the abolishment of dower rights, you may wish to seek legal counsel.
